Presbytery of Waterloo-Wellington Treasurer's Report to Presbytery at November 13, 2018

Loan request from St. Andrew's Presbyterian Church, Guelph

A request was received from the Minister at St. Andrew's Presbyterian Church, Guelph, with the support of his session, for a loan from Presbytery in the amount of \$350,000. The request, received on church letterhead and signed by the mister, is as follows:

September 25th, 2018 Dear Clerk of Presbytery,

St. Andrew's Guelph is experiencing a time of rejuvenation as a congregation of God's people on the corner of Norfolk and Suffolk Streets in Guelph. Our Rejuvenate 190 Campaign launched two and a half years ago was a wonderful success. We were able to raise \$190,000+ to replace our historic slate roof (with a steel/aluminum one), replace our sanctuary flooring, upgrade our sound system and make some repairs to our sanctuary walls to address some leaks from the old roof. At the same time, our dear "Rooster" atop our steeple was struck by lightning last summer which caused a fire and significant smoke and water damage to our steeple and narthex area. Our building insurance covered most of the expenses related to the clean-up and restoration project that followed. It was a blessing that our sanctuary and the rest of our building suffered no damage because of this incident.

I write to you today to make a request for assistance as we are now in the midst of yet another 'surprise' emergent capital project relating to the replacement of our heating system. We have had a boiler that has served us faithfully for many many years and each year we wonder if it will last one more winter. Sadly, this past winter was its last – it was determined that our old boiler system required significant repairs. It was time to consider replacement. Starting in August of this year, our Board has worked with an engineer, a contractor, and the requirements of the City inspectors to figure out what would work best in our historic building. We are moving ahead with a forced air heating system that will require a significant amount of duct work and two large furnace units – one that will be placed on our lawn and another that will be installed on the roof of our Christian Education wing. In order to meet building codes and City regulations we are being required to make several alterations to our existing building that are adding to the cost of this significant project. The best estimate to date is that the final project will total \$350,000.

We have just spent the better part of two and a half years encouraging the congregation in its generosity to raise \$190,000 for the Rejuvenate 190 Campaign and we were delighted by their response. This past year has also seen St. Andrew's Guelph supporting a large Syrian Refugee family. The congregation has offered support to the grandchildren of a previous refugee family whom St. Andrew's sponsored whose parents died in Sierra Leone. We are in process to bring these grandchildren to Canada to be reunited with their grandparents. We are also inviting the congregation to be generous in their support of another refugee family from Sudan. As you can appreciate, there have been a lot of 'asks' to our congregation members and they have responded. At its most recent meeting, our Board of Managers felt it was necessary to seek a bank loan for this capital project since there have been so many requests to the congregation of late. It is their hope that our members may continue to be generous through their support in paying down the loan.

It was decided that prior to seeking a bank loan that we might reach out to the Presbytery to determine if it could offer assistance at a time such as this.

Therefore, we are requesting that the Presbytery consider offering St. Andrew's Guelph a loan in the amount of \$350,000 under its usual terms. We would also be very appreciative if any part of that loan

might be considered as a grant to offset the financial burden that this loan puts upon our congregation. We prayerfully accept the will of the Business Committee and the wisdom of the Court in considering this significant request.

The Business Committee considered this request at length at both its October and November meetings. The treasurer also visited the church and met with the minister. He also shared correspondence with Peter Devries from the church finance team. Bearing in mind the funds available and the potential future needs of other congregations, the committee partially agreed to the above request from St. Andrew's, Guelph Presbyterian Church.

Accordingly, the treasurer will request at the November 13, 2018 Presbytery meeting, that it be moved

"That an interest free loan be extended to St. Andrew's Presbyterian Church, Guelph in the amount of \$140,000, in addition to a one-time grant of \$35,000. The loan is repayable in 10 years or less and St. Andrew's, Guelph will be required to make annual repayments of principal around each anniversary of the loan date with the full loan to be retired by the end of 2028."

Following this page, you will find a draft presbytery budget for 2019. I will address this briefly and will require a motion to approve as I need to notify our 30 treasurers very soon as they will use these assessment numbers in their own 2019 budgets. Should any amendments become necessary, such amendments can be approved at the January 2019 meeting of presbytery.

The final page of my report is the normal monthly financial report, measured against budget for the period ending October 31, 2018. The expectation is that the presbytery will end 2018 with a surplus in the general account, perhaps around twelve thousand dollars, opposite the balanced budget presented at the start of the year.

Addendum 1:

Report from Rev. Scott McAndless on his Inter-mission in 2018

I am very grateful for the opportunity that was given to me this past spring to take a ten-week intermission from my duties at St. Andrew's. I have been a full-time minister in the Presbyterian Church in Canada, now for 26 years. That means that for over a quarter century (and a very large portion of my life) all of my work and all of my professional efforts have been directed toward the maintenance and promotion of that institution. All I have done, most everything I have engaged in, has all been done with one underlying assumption: this has to be good for and helpful to the church.

I don't complain about that – it is what I signed up for after all – but I do note that, when you look at the world from that one point of view for such a long time, it begins to limit your perspective. I believe that I needed a new perspective on the work that I do and that was not going to be possible without taking an extended period of time away from the church to get the church out of my head. And so, for example, I felt that it was important that I take the first several weeks of my intermission to completely avoid any thought of the Christian church. I did not attend any worship services. I did not read any the news from the church or anything else related to the work of the church. I simply avoided it entirely.

I know, I realize that this is something that many Christians do all the time without even thinking about it, but it is literally something that I had not been able to do for years and I do believe that it helped me to gain new perspective on the church and its life. In fact, I was kind of amazed at how easy it was to put the church completely out of my mind and out of my life. That is exactly how the vast majority of people in our society today live – without sparing a moment's thought for the church and its needs.

And the first thing I realized is that I don't think that they are missing it. Oh, I am quite sure that there are many people who are suffering, needlessly, because they lack the knowledge of the good news of God's grace, forgiveness, power and strength. Even more important, they are missing out on the opportunity of living out that grace and truth in an active community, whether they realize it or not. But I didn't miss, and I expect that most people don't miss, the things that we tend to spend so much of our energy on in the life of the church. They don't miss the pressure to conform to other people's ideas of what it means to be a Christian. They don't miss the worrying about the loss of traditions or the resistance to change. They don't miss all of the worries about institutional maintenance. It makes me wonder whether sometimes we are just spending too much of ourselves in the church on the things that matter least.

But, even as I spent time away from the church, I felt the importance of my faith. I continue to love and to cherish the Bible which, for me, is the source of so much that is good. I think that one of our problems is that the church has tried to keep the Bible to itself – to use the Bible only to serve its own needs and its own purposes. I felt the need to free the Bible from the church to bring it closer to those people who do not feel as if they belong in the church. That is one big reason why, during my intermission, I spent a fair bit of time working on a project trying to bring the Bible (in particular the stories of the Bible) to people outside of the church. I created a podcast called "Retelling the Bible," in which I retold some of the great stories of the Bible without worrying about whether or not the way I was telling the story would be completely acceptable to the church. I just enjoyed the stories of the Bible as I saw them without worrying about whether my interpretation might be judged wrong by some Christian institution somewhere. I greatly enjoyed being able to approach the Bible with such freedom and I think it brought something valuable to me, something that I have been able to share with others and I will continue to do that as I continue to publish, now on a monthly basis, my podcast. You can find out more about the podcast and find out how to subscribe at retellingthebible.wordpress.com.

Having spent several weeks away from the life of the church, I finally felt that it was time for me to reapproach the church, but this time as an outsider. I spent the next several weeks of my intermission visiting churches. This is something that I have almost never been able to do in my life. I have never come to a church as an outsider. And I wanted to share with you some of the things that I learned by doing so.

First and most importantly of all, I very quickly realized how difficult it is to do such a thing. I did not find it easy at all to approach a church where I didn't really know anyone and didn't really, at least initially, want to know anyone. I just wanted to go and see what it was like and it was extremely hard even to walk through the door each time. Some of this was for some very practical reasons. I wasn't used to how things are done there

or even where to go. In one case, I walked in a door and immediately got lost, took a wrong turn, and then ended up walking out a back door by the river and almost too embarrassed to try to go in again. These kinds of experiences underlined to me just how hard it is for people who haven't been to church in a long time (or maybe not ever) to actually show up when the church is open.

I observe that churches often seem to operate under one big assumption. We assume that, if we can put on a good program – if we have an excellent worship service or music program or children's program or whatever it may be – that people will just come. I call it the "Field of Dreams" assumption: "If you build it, they will come." That may have once worked, but my experiences have shown me that it doesn't any more. When new people show up among us on their own, I hope you recognize that it was probably not easy for them to do so at all. And I hope that you realize that there are many more people who simply will not come on their own.

Many studies show that the only way that most people will come to a new church is if they are not only personally invited but also actually accompanied through the door. This is something that we all need to be thinking about as we work on church life and growth.

There was another thing that I noted in my visits. I noted that when congregations were at their most formal – when they were sticklers for their own forms and traditions – was when I usually felt most uncomfortable and out of place. It was when (either intentionally or unintentionally) that formality broke down that I felt most welcome and started to enjoy myself. This made me realize that formality in churches is something that we mostly to please those who have been there the longest. Longtime members are most comfortable when everything happens formally, but a strong and growing church cannot exist only for insiders. Informality (whether planned or not) often gives visitors the message that we are not hung up with ourselves and that we are comfortable enough with who we are to laugh, make mistakes and forgive each other with love.

Just something to think about.

Congregational Affairs Committee Report: November 13, 2018

The Congregational Affairs Committee met on Wednesday morning October 3, 10 am at Knox Presbyterian Church Guelph.

The members of the quadrant present received and discussed the written Interim Moderators reports (Appendix A) as well as a request from the session of Knox Waterloo for the appointment of Rev John Borthwick as IM at Knox Waterloo

At the October 2, 2018 Business Committee meeting a request from the session of Knox Waterloo was referred to the Congregational Affairs committee.

At the September 25, 2018 Session meeting of Knox Waterloo, the session agreed to request the appointment of an Interim Moderator (IM) for the purpose of calling a Lead minister to serve at Knox Waterloo. Knox has received notice from their ministers, Rev. Linda Ashfield, and Rev. Brooke Ashfield, indicating their time-line to retirement several years ago and invited the session to prepare for transition in ministerial leadership. Since that time, the session worked diligently in researching best practices for this transition in ministerial leadership. With the full support of Rev. Linda and Brooke Ashfield the session formally requests the Presbytery to appoint Rev. John Borthwick, the minister of St. Andrew's Guelph, to be their Interim Moderator for the purpose of calling a new lead minister. Rev. Borthwick will walk beside the session and be a guide in the process of discerning future leadership.

The CA Committee discussed this request and the following <u>Motion carried</u>: That John Borthwick be appointed IM at Knox Waterloo to help prepare for hiring a new minister. Moved by J. Swatridge & seconded by M. Hunter.

An email to this effect was sent to the Clerk of Presbytery and Rev John Borthwick after the CA meeting on Oct 3, 2018

The CA committee at its meeting Wednesday October 3, 2018 appointed Rev John Borthwick from St Andrews Guelph as Interim moderator at Knox Waterloo commencing his duties as soon as possible

Rockwood and Eden Mills October 1, 2018

Since commencing the vacancy work at Rockwood and Eden Mills it became apparent that some conversation about the future direction of this pastoral charge would need to occur before proceeding to another call. Within the Eden Mills session, we discerned the need to apprise both the Eden Mills congregation and the session at Rockwood of the inability to enter into another call on the 50/50 cost-sharing basis, as such a move would cause Eden Mills to arrive at a point, within 2-5 years, of not being able to meet its financial commitments. I moderated a congregational meeting on Monday, June 25 to explain the situation, outline some options, and seek the congregation's will for its future direction. Session also prepared a questionnaire, which was circulated to all members and adherents, and which resulted in a clearly preferred direction to pursue: amalgamation, though not along a model of absorption into Rockwood where all future worship would be at the Rockwood site. (Eden Mills and Rockwood have some experience of worshipping together in the summer months, and Eden Mills members find the paucity of parking at the Rockwood site already a deterrent to their attendance). At a joint meeting of the Eden Mills and Rockwood sessions on June 28, the Rockwood session was advised of the situation, and began its own thinking about possible future options. I moderated a congregational meeting at Rockwood on September 10th at which the mandate was given to the Rockwood session to explore potential partnerships with other local area churches. On September 17th the Rockwood session met with the session of another local church and plans to carry forward this exploratory work over the coming months. Meanwhile, the Eden Mills session has identified 5 local-area churches whom it would like to approach about potential partnership or amalgamation.

As both Rockwood and Eden Mills are on the Easternmost boundary of Waterloo Wellington Presbytery, our consideration of options for future partnerships have ranged over the points near the Westernmost boundary of Brampton Presbytery as well as points within the Guelph quadrant of our own Presbytery. As Interim Moderator I have told the congregations that I do know of examples where congregations were transferred with seemingly little fuss from the bounds of one Presbytery to another, but that it would be good to advise Presbytery at an early juncture that a trans-Presbytery solution is a possibility and seek Presbytery's advice about how we would proceed in such an eventuality.

Understandably there is a bit of anxiety in the two congregations about what the future will hold, and how long it is likely to take before stability can be restored in the shape of a settled minister. The recent resignation of Fitz Bharath as organist at Rockwood (as of September 30, and at Eden Mills as of June 24) is also a loss deeply felt at Rockwood in particular. However, the congregations are being well-served in the interim period by a small rota of well-regarded supply preachers. As interim moderator I led a 4-week summer Bible study for the joint charge at the Rockwood site in August and have scheduled myself on the preaching rota every couple of months, which opportunities I can use to update the congregations. I was also pleased to be able to engage

Mike Wasyluk, the Presbytery's Emerging Generations facilitator, to lead a workshop on understanding millennials, scheduled for Saturday November 3, and to enrol 2 participants from the Rockwood congregation in the Presbytery's Missional Imagination course. Understanding congregational culture and the development of missional thinking, must be a part of the work of setting up these two congregations for future health and sustainability, for without it, structural reconfiguration will, at best, provide a short-term solution.

1) Requests for Student Ministry Funding:

The Mission and Outreach Committee is very thankful for these ongoing ministries and for the opportunity that we all have as a Presbytery to be a part of them. Thanks be to God!

We have discussed the matter with the treasurer who is concerned that we must be careful not to overinflate the budget. He is especially concerned that there may be a severe drop in revenues starting in 2020. For this reason we want to exercise some constraint on any growth in this funding. We have formulated a motion that keeps increases within 3% as follows.

The committee was also somewhat concerned that it is difficult to judge and compare these outreach programs because the reports and requests come in such varying forms. We would like to address that for future applications.

Recommendation 1: That the grant for Student Ministry funding in 2019 be \$16,900, allocated as follows:

Joonim \$3400 Doon \$3000 Knox Waterloo \$5500 Kortright \$5000

Recommendation 2: That the committee do some thinking about this project, its purpose and successes and potential sources for ongoing funding. The committee will also circulate a template to all congregations by February 2019 that they may use for applications for student ministry funding in 2020.

2) Use of the Emerging Generations Fund

The committee is concerned that congregations have not been making use of funding from the Emerging Generations Fund. Part of the problem is that there are no guidelines for congregational applications. It is our feeling that this should be addressed.

Recommendation 3: That the Business Committee create guidelines, to be approved by the Presbytery, for how congregations may apply to the fund, what sorts of new (or existing) initiatives will be supported and for how long, and that these guidelines be circulated to all congregations.

3) Funding for Two Rivers:

In 2017, Mission and Outreach recommended a \$20,000 grant each year for three years to support the growing ministry of the Two Rivers Mission. The Presbytery, in its wisdom, granted one year's funding with the understanding that we could return to the question this year. We propose the same grant for 2019. This amount needed for Two Rivers' budget is predicated on how much they can receive from Canada Ministries. They have requested (with our approval) \$10,000 from Canada Ministries. Unfortunately, Canada Ministries response to this request will come only two days after Presbytery. In response to all of this, we make the following motion:

Recommendation 4: That the Presbytery grant up to \$20,000 from the Development Fund to the Two Rivers Mission in 2019 and that this grant be conditional on them receiving the amount (or close to the amount) they have requested from Canada Ministries.

4) Update on the Missional Imagination Course.

First Weekend: September 21 & 22, 2018

We had a great first weekend! In the end, we had a total of 29 people registered for the course. On the first evening, we had many guests come and check it out the course as well.

The first evening we learned about the theology of mission and the spirituality of mission. We participated in a Lectio Divina exercise.

On Saturday, we walked around the neighbourhood and noticed evidence of both the world's pain and the world's joy in that local neighbourhood. We also saw many opportunities for partnership in that local neighbourhood. We were able to share and learn from one another in table group discussions after this walk.

In the afternoon we looked at many different approaches to mission: Eucharist mission, social engagement, and the church as a guest rather than a host. We were all left with lots to think about!

The venue and the food at Knox Waterloo were fantastic!

We look forward to our next weekend on November 23 & 24 at Kortright in Guelph.

Appendix F - Education, Issues, and Fellowship Committee—Rev. Ed. Charlton

EIF Committee Report for November 13th, 2018

The EIF Committee is working on organizing two workshops and a potential course. The Workshops are; 1. For Church Treasurers and those interested in the role and responsibilities of church Treasurers, 2. Boundaries and How to protect against Sexual Harassment. The potential course is to help develop lay preachers.

Treasurers Workshop

We have engaged with the financial services department of the Presbyterian Church in Canada, more specifically with the CFO Oliver Ng. We will be having a workshop on the morning of May 11th. The location will be at Gale Presbyterian Church in Elmira. This workshop was brought to the EIF Committee to put together to help out the treasurers in our Presbytery. We would need roughly \$500 for this workshop for rental costs, food, and possible honourarium.

Recommendation 1

That the Presbytery of Waterloo-Wellington approve the Treasurers Workshop with the budget of \$500 to come from the conference fund.

Boundaries and How to protect against Sexual Harassment

We as teaching and ruling Elders are called to serve and care for people. We need to keep honing our caring methods and practices so that we will be caring for people, caring for ourselves and our communities in a safe and Christ loving way. We cannot afford to not take the time to do this as we see around our society that people have been hurt because some did not take this seriously or were completely ignorant about how their words and actions were hurting people. This is not just about our own protection, but we are seeking to glorify God with all our words and actions as we share the Gospel. Some of the Laws have changed since many of us took the required course, some of the practices have changed. We need to stay up to date as people who are caring for a hurting world.

At this moment we do not have a set date or time. We are looking into a workshop that is providing through 50 Wynford Drive. We were also made aware of a similar workshop that is put on in Waterloo through Conrad Grebel University College on January 31-Feb.1 2019 called Nurturing Healthy Boundaries in the Context of Ministry: Creating a Safe and Respectful Congregational Culture. The Cost of this workshop is \$275 + HST.

We are looking at making this a required workshop, we have not gone down that road yet because we do not have the logistics set up to even have the workshop. We are looking at the possibility of running our own workshop at multiple times realizing that there is not one date that works for everyone.

Strategic Planning Fund

Westside Presbyterian Church has engaged in the process of long-range strategic planning, engaging the congregation in dialogue, prayer, visitations, and even having a Celebration banquet. From all the work that they have done in 2017 to today, they have seen results manifest. They are requesting \$3000 to cover part of the costs that they have already incurred in this process.

Recommendation 2

That the Presbytery of Waterloo-Wellington approve the \$3000 request from Westside Presbyterian Church coming from the Strategic Planning fund.

Lay Preaching Course

The prospect of this course was first presented to Presbytery in June. This came out of a realized need for more people to be able to lead worship services and preach the Gospel. As stated, before we have more ministers taking sabbaticals, holidays, study leave, sickness, parental leave, and vacancies which are putting a strain on pulpit supply. Pastor Edward Charlton suggests that this

could also be time to look at our ministry models of equipping people to preach not out of necessity but out of equipping the body of Christ to be leading worship and preaching. By bringing up more people we have the opportunity to hear and see the moving of the Holy Spirit. It also brings a wider ministry base for the body of Christ to be moving in the world and in this community.

The Committee is aware of one person who is developing a course similar to what we are looking for. We are also looking to see what is out there on the internet or other courses that are available and will help bring up people who are led to be part of this type of ministry within congregations.

One item that we need to recognize is that this will cost money. As a presbytery it would be wise if we start to prepare for this, 1) who are these perspective people, 2) who is going to be funding this.

Cyclical Program

Letter from Jen de Combe for Presbytery

The Life and Mission Agency is embarking on an exciting initiative designed to encourage presbyteries and leaders within The Presbyterian Church in Canada to take first steps towards starting new worshipping communities. This initiative, Cyclical PCC, will provide a framework that includes:

- A multi-day in person assessment program to help participants discern their gifts in the areas related to starting new worshipping communities (in Vancouver, Jan. 23-25, 2019 or in Toronto, Feb.27-Mar. 1, 2019).
- Training to equip participants for the challenges of starting new worshipping communities, including a multi-day training event (in Toronto, May 13-16, 2019).
- A community of support and learning provided through a coach and a cohort of 10 participants that will meet online monthly.

Cyclical PCC is drawing upon proven models designed to create an ecosystem for church planting. Rather than focus on the individual "plant", the system works towards tending a garden where leaders are grown and equipped to discern what the Spirit may be doing in and through them to start a new worshipping community.

This approach, rooted in the Scripture, takes courage and trust. God forms and calls us in community and God works through the lives of individual leaders, especially when something bold or new is about to take place. We can think of Abraham, Sarah, Joseph, Moses, Deborah, Elijah, Mary, Paul, and of course, many, many others. God speaks in whispers or in blinding flashes with a call to something new.

Presbyteries play a vital role in nurturing leaders, yet it is challenging to provide the space where a potential call and vision might be appropriately discerned, shared, nurtured, and tested. Cyclical PCC provides presbyteries with an opportunity to encourage and support individuals who might be instrumental leaders in starting new worshipping communities.

Your presbytery is invited to identify potential leaders within your bounds and to encourage them to apply to be part of Cyclical PCC.

With this letter, I am sending a list of Frequently Asked Questions, a list of characteristics of people who might be a good fit for this ministry, as well as the definition of a New Worshipping Community. Further information and the form to begin the application process can be found at Presbyterian.ca/cyclicalpcc/
